3. Proof of financial responsibility (automobile liability insurance) with name of Defendant on the policy
4. Certified 3A driving record from the Texas Department of Public Safety within ten (10) business days to the Court (this can be faxed, mailed or emailed) you can get that record at: <https://txapps.texas.gov/tolapp/txldr cdr/TXDPSLicenseeManager>
5. Pay Court Cost of **\$144.00** (\$169.00 if in school zone) and submit proof of payment to the Court if payment was made online, by email, fax or mail. The website to make payment is [www.go2gov.net/go/buckholts](http://www.go2gov.net/go/buckholts)

Should I fail to complete my course or submit my signed certificate by the date given, or fail to comply with any of the above, I understand I will need to appear at a show cause hearing. If I fail to appear at that show cause hearing, the Court will impose the full fine, enter a judgment of conviction and may issue a warrant for my arrest.

The undersigned Defendant, upon entering a plea of guilty or no contest to elect completion of the Driver Safety Course, for dismissal of a moving violation, acknowledges that he/she has obtained disclosure of any timely requested discovery material in the State's possession pursuant to Art. 39.14 of the Code of Criminal Procedure, including but not limited to, the offense and/or reports, audio or video reports or any other discoverable evidence that may exist.
